

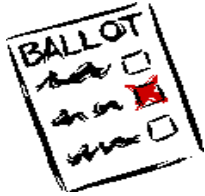

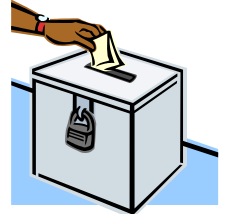

SELECTION OF DELEGATES AND ALTERNATES
FOR PASSAIC COUNTY FOR REPRESENTATION
TO ELECT A TRUSTEE POSITION
(TEACHERS' PENSION AND ANNUITY FUND)



THE TEACHERS' PENSION AND ANNUITY FUND (TPAF) BOARD OF TRUSTEES HAS DETERMINED THAT PASSAIC COUNTY IS ENTITLED TO 22 DELEGATES AND 11 ALTERNATES FOR REPRESENTATION TO ELECT A TRUSTEE POSITION (IF NECESSARY) FOR A THREE-YEAR TERM COMMENCING ON JANUARY 1, 2016, FROM GROUP B. THE DELEGATES AND ALTERNATES MUST BE ACTIVE OR RETIRED MEMBERS OF THE TPAF.

N.J.A.C. 17:3-1.4 SETS FORTH THE PROCEDURES FOR THE SELECTION PROCESS OF A MEMBER-TRUSTEE. THE INTERIM EXECUTIVE COUNTY SUPERINTENDENT OF SCHOOLS ESTABLISHES AND IMPLEMENTS THE PROCEDURE FOR THE SELECTION OF DELEGATES AND ALTERNATES SHOULD THE NUMBER OF INTERESTED MEMBERS EXCEED THE ALLOTTED NUMBERS.
